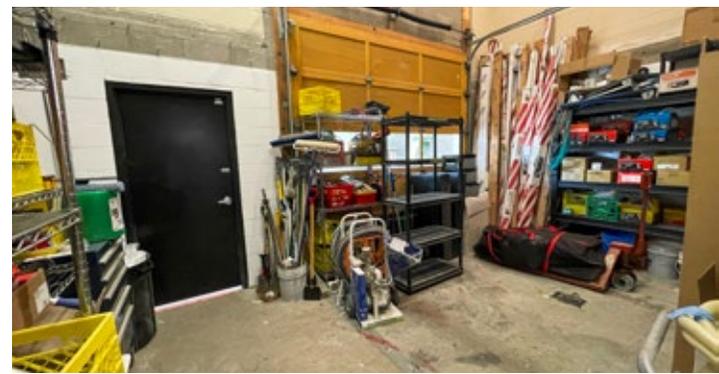
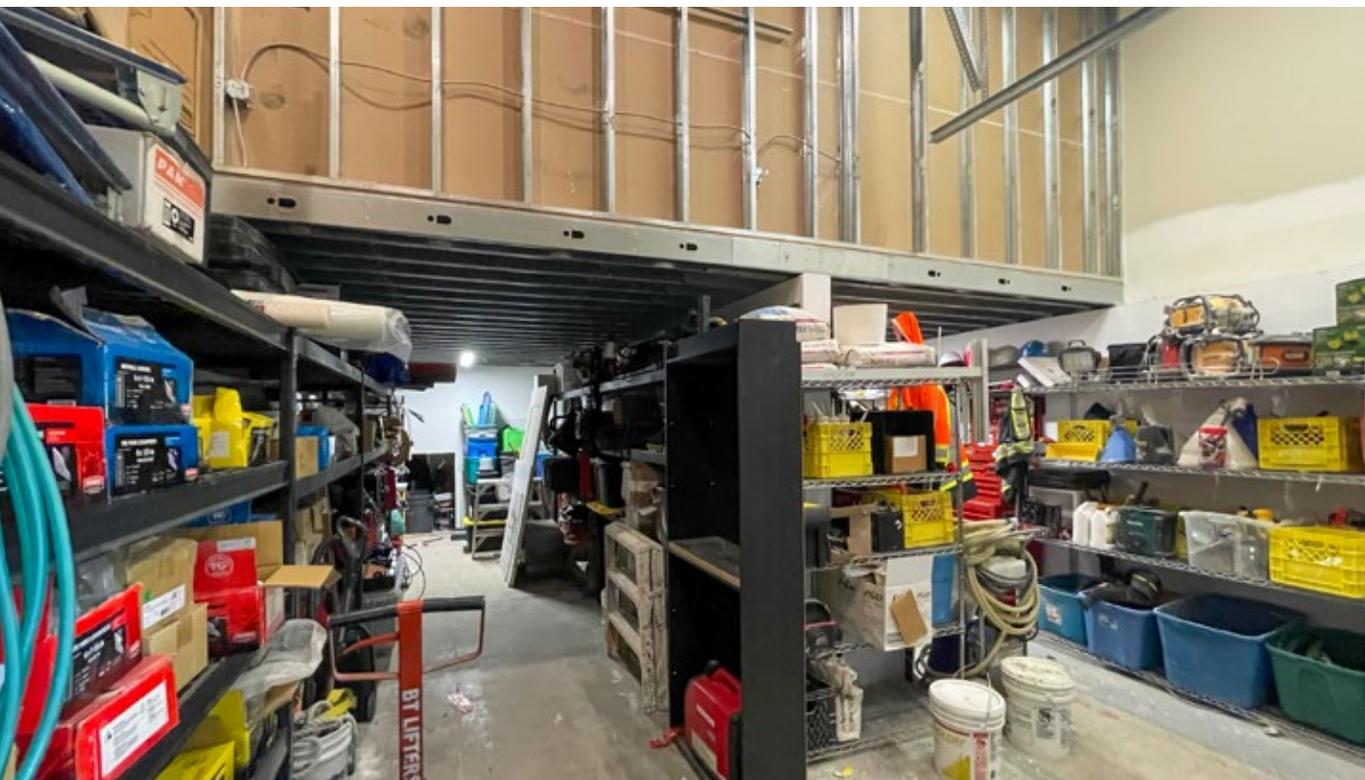
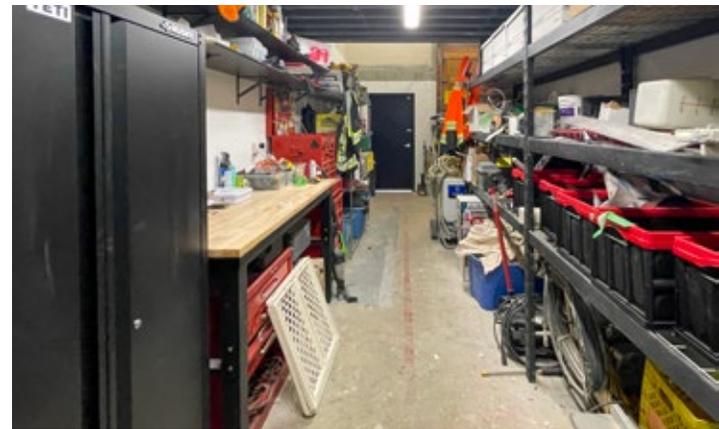
# Floorplan
